### French duped in recent consultations about DST ("summer time")

ACHED - French Association Against Double Summer Time - For the reduction of time advancements - Association Act 1901 since 1983

- DST, time changes and legal time in France: the ACHED Association denounces the consultation conducted among French nationals by the Commission of European Affairs (CAE) of the National Assembly (NA) in February. **Whatever the results, the ACHED termed them as unusable** even before the closing of the collection on internet on March 4th. Biased, irrelevant questions, exclusion of a segment of the population, anonymous and multiple responses, media circus and ballot stuffing were additional to the **historical misinformation**.
- Since 1976, the introduction of UTC+2 forward time change in the Spring with fallback to UTC+1 in the Fall, **the French people are fooled and abused with alleged benefits and savings** described to come from being two hours ahead of their standard time UTC + 0 and coined with the **misleading name "summer time"**. The ACHED points at **errors and omissions** in the French and European reports relayed by the media. Whole reports are even **missing**.
- ACHED also complains about **amnesia** of the European parliamentary and executive bodies which extends to the European Affairs Commission (CAE). In particular, the **Council of Europe** in 1999, followed by the **French Senate** in 2001, asked the governments to stop applying UTC + 2. Chronobiology received Nobel Prize in 2017 and further support comes from the chronobiologists of the EBRS with an official letter dated October 2018. It makes it clear that UTC+2 is a nuisance for the French, Spaniards and inhabitants of the Benelux. "Summer time" hour is not a recommended option as putting babies on their stomach isn't either. **People are not consulted about: "BABIES on their stomachs or on their backs?" So why asking them "SUMMER TIME or WINTER TIME? ?"**
- The presentation of the results of the consultation has been announced for the 12th of March at a meeting of the AE Committee at the AN in Paris, but **apparently official(?)** information has once again been given to the media. The situation is serious! France risks driving its neighbors into increasingly irresponsible choices, as it did in the 1970s and 1980s. **With UTC + 2, the health, pecuniary and climatic bills could explode.** The bill is already heavy with 7 months per year, that French are distracted from noticing. Extending UTC+2 to 12 months has not been properly studied, but it is clear that citizens will be hurt even more **They will continue to suffer and will further compromise their future and situation with climate change.**
